Rustin Casey Begins Work as New Community Manager

New Landscaping Contractor, Carescape Arrives Onsite

A new landscaping contractor, Carescape Landscape Management, started service to Mirage Crossing on May 1. They will be onsite full days Tuesday and Thursday.

During the months of January and February the Board reviewed five contractor proposals to provide landscape service to our community. The Board voted 5-0 on March 28 to contract with Carescape Landscaping based in Mesa AZ.

All service from Gothic Landscaping ended April 30. Our contract with them was severed by the Board due to overall dissatisfaction with their service. We gave Gothic the required 30-day notice of contract termination so that Carescape Landscape could begin service on May 1.

Owners and Residents should see an improvement in the community landscape once Carescape has some time to catch up with neglected areas. Some of the improved services the Carescape contract includes: landscapers on site for 8-hour days when on site, landscaping debris cleaned up promptly, dead plants removed quickly. Missed dates due to weather will be made up and the crew will be supervised onsite. All onsite personnel will be uniformed.

The Carescape service contract is double what was paid to Gothic last fiscal year. All the bids received were in the same cost range including the new Gothic bid. The Board will have to rearrange the budget this year and in future years to be able to absorb this cost increase.







New Manager Started Work On-Property on May11

Be Careful: Hot Surfaces for Pets

Doctors who work in the Arizona burn center are warning people of injuries from contact with super-heated roadways, sidewalks and other surfaces as the extreme heat of the Arizona summer has now started. Health officials advise people to be mindful of the burn potential of hot asphalt, sidewalks and even desert sand for both people and pets.

When the outside temperature tops 100 degrees, pavement or asphalt at two o'clock in the afternoon in direct sunlight has a temperature somewhere around 180 degrees Fahrenheit, so it's vital to be aware of the difference between pavement and air temperatures. Walking without shoes on asphalt in the Arizona summer sunshine can actually cause third degree burns. Burns can also happen after touching hot surfaces like metal door handles, seat belt buckles or hot leather car seats.

Cats and dogs have sensitive paw pads that become quite vulnerable in the heat. Surfaces such as pavement, asphalt and artificial grass can become very hot causing blisters or burns on their paw pads. It only takes 60 seconds on pavement that is 125 degrees Fahrenheit for a dog's paws to burn. So be careful out there....
